Applicants are requested to check the Draft Merit List specially Passed/Appeared, Percentage of Hons. Marks, General Marks, SC, ST, OBC-A, OBC-B, PWD status, Year of Passing, Order of Preference of Course(s) OR Omission of Name from list within the **stipulated date & time mentioned in the Admission Schedule available in the admission portal**. **No claim for correction will be entertained later.**

Part – A: Consisting of the Applicants who have (PASSED) graduated from C.U. affiliated Colleges including C.U. Autonomous Colleges in the years 2020 & 2019.

Part – B: Consisting of the Applicants who have (PASSED) graduated from Other University in the years 2020 & 2019.

Personal information may be corrected by the candidate himself/ herself by login into the admission portal by using his/ her user ID (Application number) & Password.

Change of Order of Preference may be allowed, even new course within the same application group may be added but **change of group** (i.e., addition or deletion of any group) **will not be allowed.**

For change of Order of preference candidate have to login into the admission portal by using his/ her user ID (Application number) & Password and have to submit his / her proposal for revised order of preference. Thereafter, admin will approve the prayer if desired ok)

Registration information (like name , Mobile no., E-mail ID , C.U./Non C.U. , C.U. Registration No.) **cannot be changed** by the Candidate himself/ herself.

Academic details cannot be changed by the Candidate himself/ herself.

For any correction in Registration information & Academic details Candidate have to **e-mail to the helpdesk** (cuadmissionhelpdesk@gmail.com) for correction by using format-I (given below, also available in Section 16 of the Information Brochure) with relevant documents.

After preliminary correction, a provisional merit list will be published, which will be notified in Admission Schedule.

N.B.: The Rank in the Draft Merit List is **not the Final Rank**. Mere fulfilment of eligibility criteria does not guarantee admission in a programme. Applicants must satisfy themselves about their eligibilities as prescribed before filling in the Application Form. Overlooking of any information will not be claimed as right.
